Responsibilities/Duties

Responsibilities/duties include, but are not limited to:

- Develop and teach on-campus and online courses in the Master's, Post-Master's Certificate, and Doctorate of Clinical Nutrition curricula, including creating syllabi, lesson plans, and assessments appropriate for graduate level coursework (i.e., incorporating critical thinking and information literacy), integrating computing, academic technologies, and the University learning management system into the subject material
- Supervise clinical experiences and capstone projects
- Assess student learning outcomes, including grading and reviewing assignments
- Monitor student progress and grades
- Participate in faculty meetings as well as academic and University committees
- Provide individual coaching/advising of students as required
- Participate in program related events as appropriate
- Engage in collaborative relationships to promote positive community relations on behalf of MUIH and Nutrition and Integrative Health programs
- Demonstrate professional knowledge, attitudes, skills, and standards of conduct
- Perform other duties as assigned
